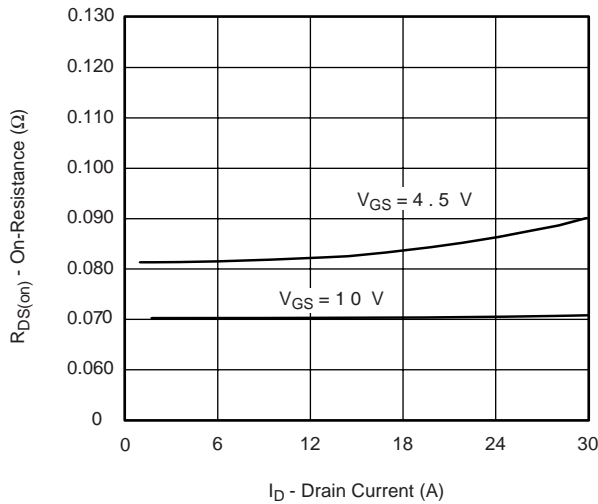

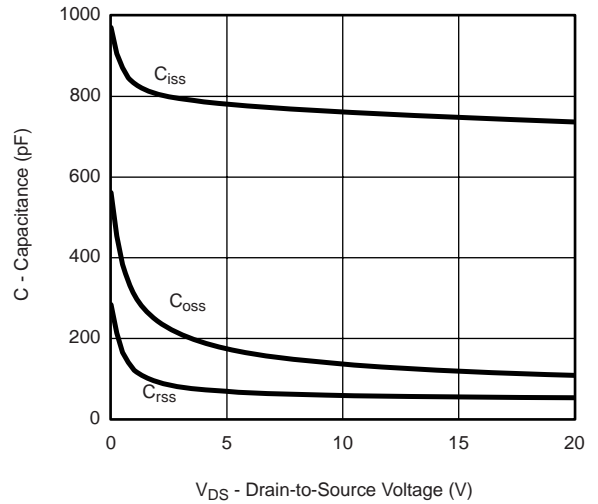
V_{DS} - Drain-to-Source Voltage (V)

Transfer Characteristics



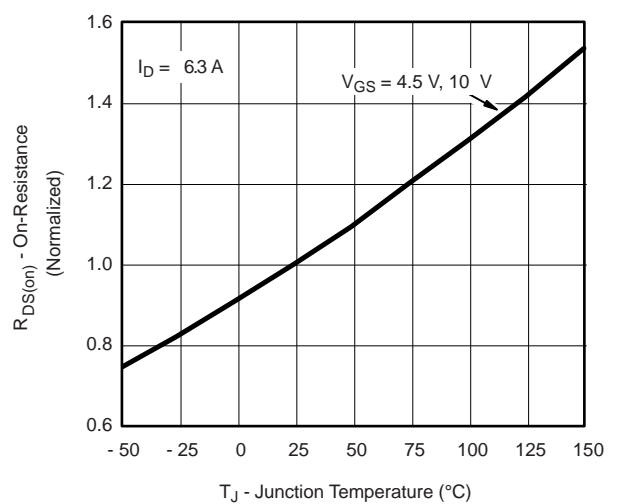
I_D - Drain Current (A)

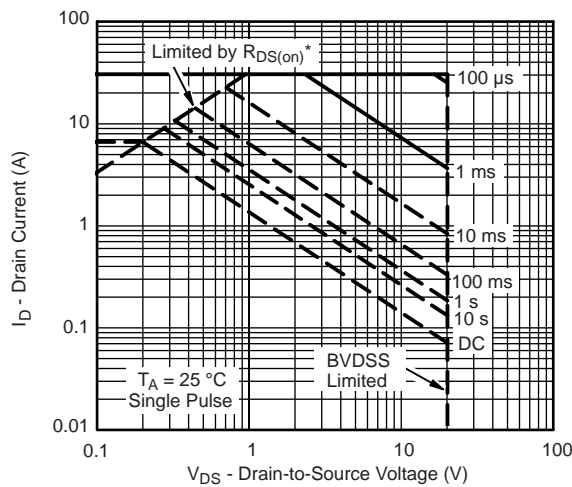
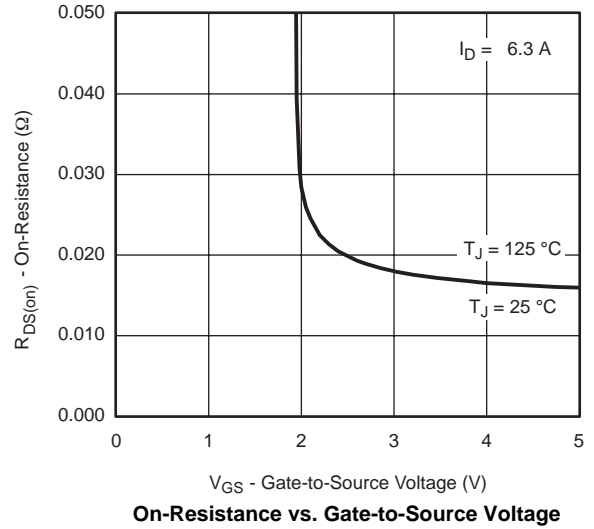
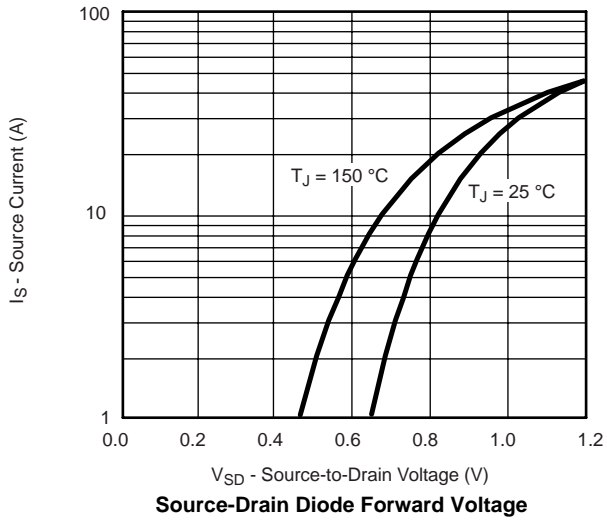


Q_g - Total Gate Charge (nC)

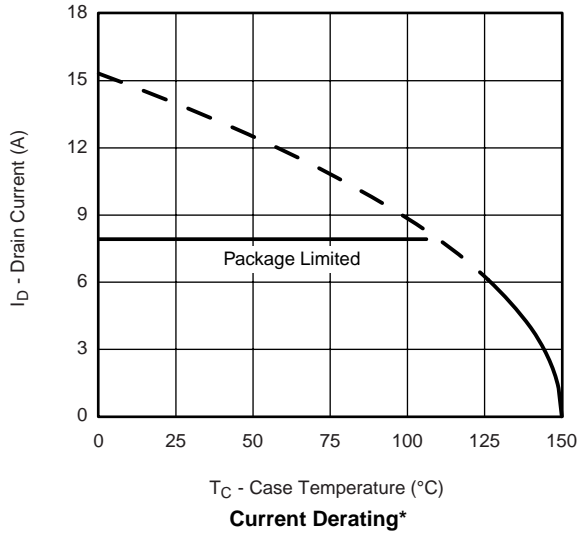
T_J - Junction Temperature ($^\circ\text{C}$)

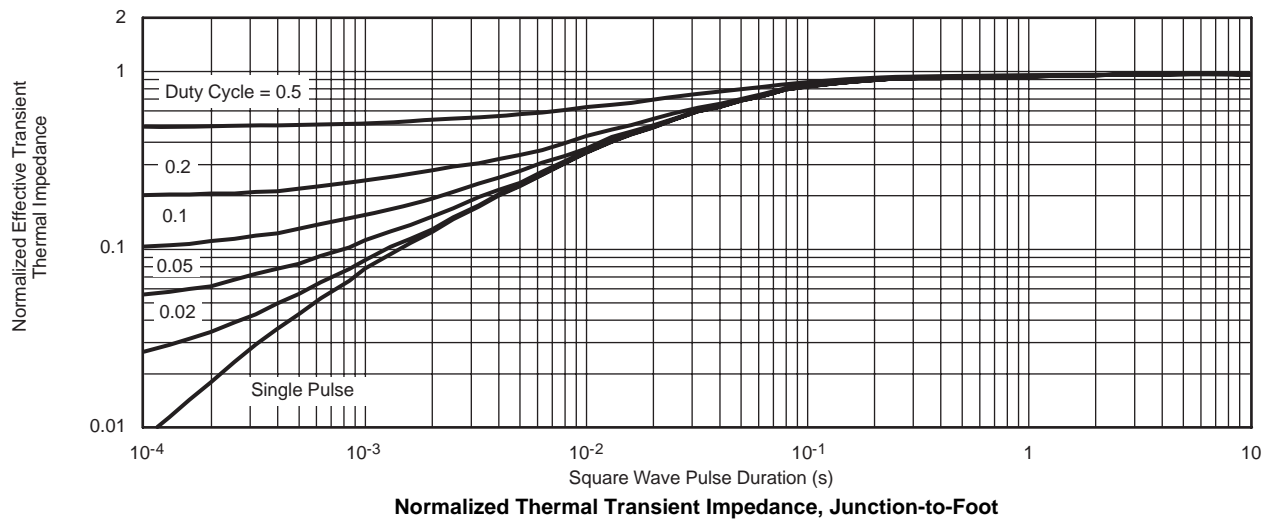
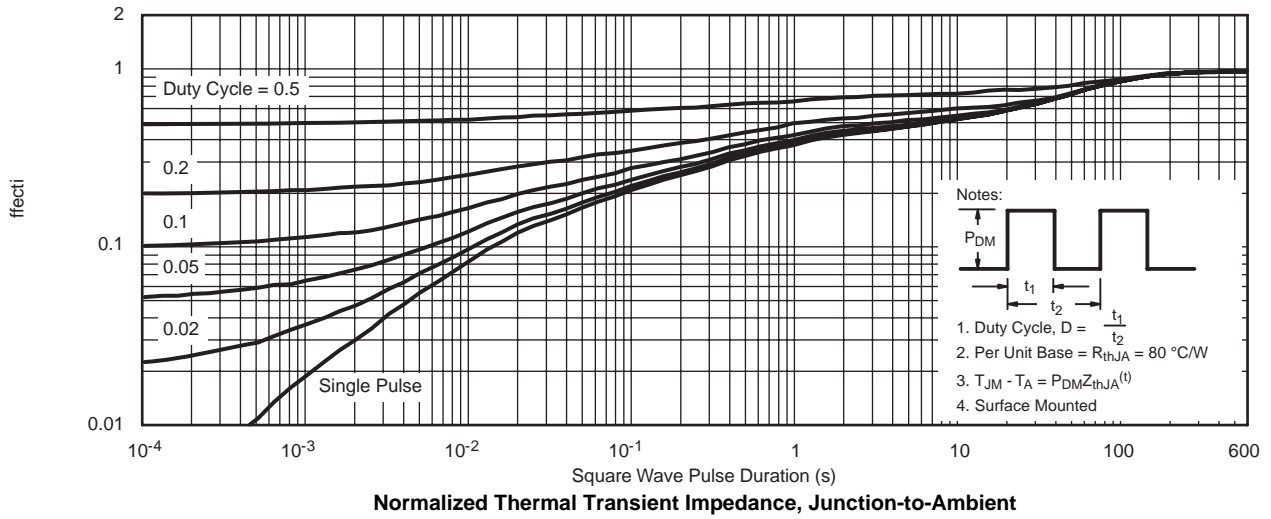

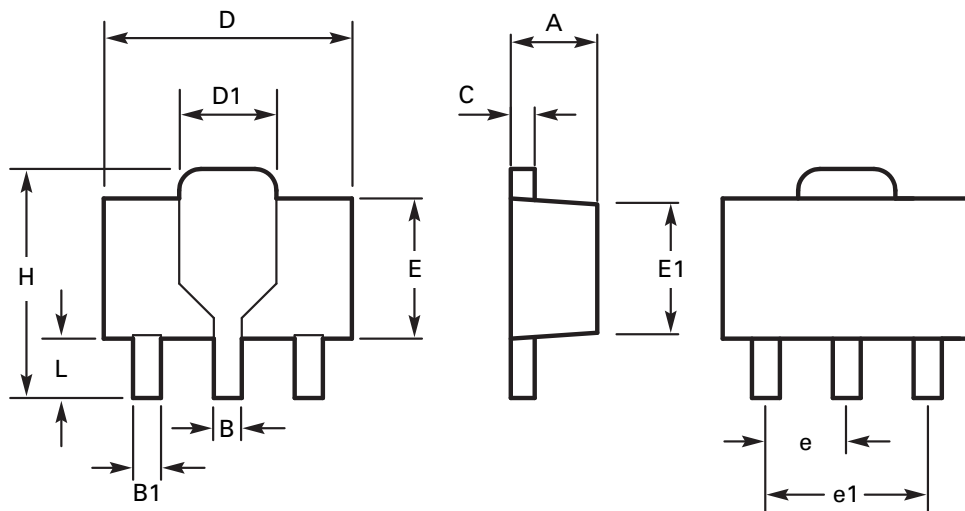
